Incoterms (BCC Accredited) Incoterms [®] (International Commercial Terms) comprise some of the most widely used, but most misunderstood aspects within international trade; they can impact on a number of areas of a company's operations, including sales, accounts, operations, compliance and customer service. At the beginning of 2020 we saw the introduction of the latest version of Incoterms known as Incoterms 2020.	Monday, 9 th November 2020 (am)
Methods of Payment and Letters of Credit (BCC Accredited) With over 75% of first presentations to banks against letters of credit being rejected, businesses are aware of the additional costs discrepancy fees can incur. This course aims to provide delegates with detailed information on how to be pro-active in opening a Letter of Credit, how to work with the documents and present to the bank correctly.	Monday, 30 th November 2020

Customs Grant Scheme - £50 million now available

From 29 July 2020, organisations can apply for funding to reimburse a number of costs associated with increasing their capacity and enhancing their ability to complete customs declarations, ahead of the new rules from January 2021. Eligible organisations can apply for funding for recruitment, employee training and IT, in preparation for additional customs declarations. <u>Click here</u> for full details.
