# Carbon Border Adjustment Mechanism (CBAM)

**UK:** HM Treasury has agreed in principle to introduce a UK Carbon Border Adjustment Mechanism (CBAM) covering imports in several sectors by January 2027. Goods imported into the UK from countries with a lower or no carbon price will have to pay a levy, ensuring products from overseas face a comparable carbon price to those produced in the UK.

**EU:** Wednesday 31<sup>st</sup> January 2024 is the deadline for the first reporting period in the EU's CBAM covering embedded carbon emissions in non-EU exports in six key economic sectors. Make sure that you are speaking with your EU customers about what information they require from you in order for them to make their declarations.

### **Russia Sanctions**

The UK government has issued a <u>General Trade Licence</u> covering some goods affected by the Russian steel sanctions legislation.

A **7th round of sanctions** on Russia by the UK government has come into effect. Measures also now include a ban on diamonds and diamond jewellery imports from Russia.

A new **Office of Trade Sanctions Implementation (OTSI)** will be created to clamp down on companies dodging strict trade sanctions, including those imposed since the war in Ukraine. <u>Click here</u> for more details.

## **ATA Carnet Urgent Update**

**Stop 24** no longer offers stamping of ATA Carnets.

**Dover Western Docks** will only give ATA endorsement through commercial operations.

### **CDS Exports/Imports**

HMRC has updated their timeline for CDS **export** go live dates:

- -GVMS supported exports (Ro-Ro) Live and available
- -Air exports available from 31/02/2024
- -Sea exports available from 31/03/2024
- -NES exports to close on 31/06/2024

#### **XI EORI for NI Shipments**

When submitting CDS import entries for goods moving from the UK to NI, it is mandatory to declare the importer's XI EORI rather than the GB EORI number – effective as of 19<sup>th</sup> December 2023.

# Border Target Operating Model (BTOM) New Import Controls from 31<sup>st</sup> January 2024

### New Import Controls from 31st January 2024

Changes coming in on 31<sup>st</sup> January:

- -The introduction of health certification on imports from the EU of **medium risk**:
- =animal products
- =plants
- =plant products
- -The introduction of health certification on imports from the EU of **high-risk** food and feed of non-animal origin
- -The introduction of new checks and controls when moving Irish goods (i.e., any goods other than <u>Qualifying Northern Irish Goods</u>) from Irish ports directly to Great Britain

### Things to help you prepare for the changes

- -Know your risk-category use these online tools to find the risk category of your commodity
- -Ensure that your EU supply chain is preparing to provide you with health certificates and/or phytosanitary certificates find out more <u>here</u>
- -Be ready to correctly submit your pre-notification in IPAFFS attend a <u>January training session</u> or read the guidance from DEFRA <u>here</u>
